**SUBJECT:** PY 2001 WIA TITLE I - Additional Youth Allocations

1. **Purpose:** To issue PY 2001 WIA TITLE I - Additional Youth Allocations to Local Workforce Investment Areas and to provide procedures for accessing subject funds.
2. **General Information:** On August 16, 2001, TEGL No. 3-01, PY 2001 Changes in Dislocated Worker and Youth Funds was issued to the employment and training system. The TEGL stated that an additional \$25 million is being made available for Youth activities in PY 2001 as a result of the Supplemental Appropriations Act, 2001 and that individual state allotments would be forthcoming.

On August 24, 2001, TEGL No. 3-01, Change 1, PY 2001 Youth Supplemental Funds was issued to the employment and training system. Attachment A, to the TEGL contained the individual state allotments referenced above.

The additional funds allotted to the State of Arkansas for Youth were allocated to the Local Workforce Investment Areas using the same methodology as the initial formula allocations. On October 9, 2001, The Arkansas Workforce Investment Board approved the allocations.
