1. **Purpose:** To provide PY 2003 WIA Title I – Youth, Adult and Dislocated Worker Subgrant Award numbers and funding amounts to Local Workforce Investment Areas.
2. **General Information:** This Issuance provides PY 2003 Subgrant Award numbers and funding amounts for one hundred percent (100%) of Youth allocations, for twenty one percent (21%) of Adult allocations, and for twenty six percent (26%) of Dislocated Worker allocations.

The performance period for your Subgrant Awards should be April 1, 2003 through June 30, 2005 for Youth; and should be July 1, 2003 through June 30, 2005 for Adult and Dislocated Worker.
