SUBJECT: PY 2005 Workforce Investment Board's WIA Performance Incentives Grants

TO: Local Workforce Investment Areas/Service Providers

- Purpose:** To issue procedures for applying for subject funds.
- General Information:** On April 11, 2006, the Arkansas Workforce Investment Board approved the award of \$300,000.00 out of WIA 15% Funds to Local Workforce Investment Areas for Program Year 2004 WIA Performance Incentives.

In accordance with WIA Regulations, these funds may be spent for any allowable WIA activity. These funds may not be used for administrative costs and local areas will have until June 30, 2007 to expend these funds.

The chart below details the incentive awards for each of the 10 local workforce investment areas.
