**SUBJECT:** PY 2006 WIA Title I, Final Allotment – Revised Youth and Adult Subgrant Award Numbers and Additional Funding Amounts.

**TO:** Local Workforce Investment Areas/Service Providers

- Purpose:** To officially issue PY 2006 WIA Title I Final Allocation for Youth and Adult to Local Workforce Investment Areas due to additional funding amounts for PY06.
- General Information:** Youth allocations were computed according to the Workforce Investment Act of 1998, Public Law 105-220, Chapter 4, and Section 128(b)(2). Adult Allocations were computed according to The Workforce Investment Act of 1998, Public Law 105-220, Chapter 5, and Section 133(b)(2)(A). The final PY06 Subgrant Award numbers and funding amounts are 100% for Youth and 17.61% for Adult.

The information below reflects the total allotment to the State of Arkansas for each funding stream, the reservations for statewide activities required under Public Law 105-220, Chapter 4, and Section 128 (a) and Chapter 5, and Section 133 (a)(1), and the reservation for Statewide rapid response activities required under Public Law 105-220, Chapter 5, and Section 133(a)(2).
