**SUBJECT:** PY 2011 WIA Title I – Youth, Adult and Dislocated Worker Activities Sub Grant Award Numbers and Funding Information

1. **Purpose:** To provide PY 2011 WIA Title I – Youth, Adult and Dislocated Worker Activities sub grant award numbers and funding information to local workforce investment areas.
2. **General Information:** This Issuance provides PY 2011 sub grant award numbers for all three funding streams. It also provides base funding amounts as follows:
  - Youth Activities – April 1, 2011
  - Adult and Dislocated Worker Activities – July 1, 2011.

Because DOL “is in the process of seeking clarification from Congress on which limit (i.e., 5 or 15 percent) should be applied to the “advance” portion of the Governors’ reserve, and will provide guidance on the use of the “advance” funds as soon as more information is known.”, we will inform local areas as to their October funding amounts as soon as DOL publishes their guidance.

The performance period for your sub grant awards will be April 1, 2011 through June 30, 2013 for Youth Activities; and will be July 1, 2011 through June 30, 2013 for Adult and Dislocated Worker Activities.

**3. Action Required:**

- Youth Activities sub grant award packages must be submitted as soon as possible. Adult and Dislocated Worker Activities sub grant award packages are due to the Arkansas Department of Workforce Services, Office of Financial Management and Administrative Services on June 15, 2011.
