**SUBJECT:** Program Year (PY) 2010 Workforce Investment Act Performance Incentive Grants

- 1. Purpose:** To issue procedure for PY 2010 incentive award distribution.

**General Information:** The provisions of Section 134(a) (2) (B) (iii) of the Workforce Investment Act (WIA) of 1998 authorize the State to award incentive grants for exemplary performance by the local workforce investment areas (LWIAs). A total of \$250,000 in WIA Title I funds will be distributed to qualifying local areas for exceeding performance standards for PY 2010. Local areas will have until June 30, 2013 to expend PY 2010 incentive funds.

These incentive funds are awarded across programs as follows: 33.3% Adult, 33.3% Dislocated Worker, and 33.3% Youth.

The chart below details the incentive awards for each LWIA.
