



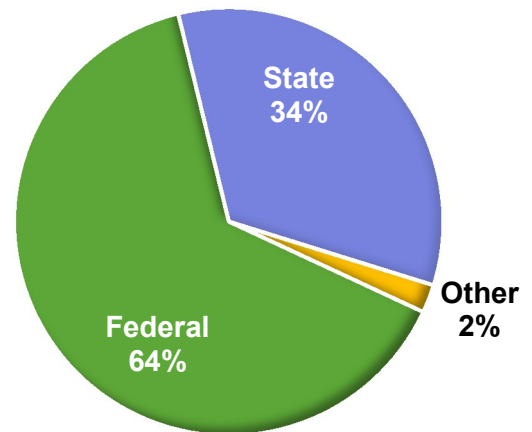
**Workforce Development Program Survey**

The following information was requested from all fifteen State Departments on programs dedicated to workforce development that operated in Fiscal Year 2022:

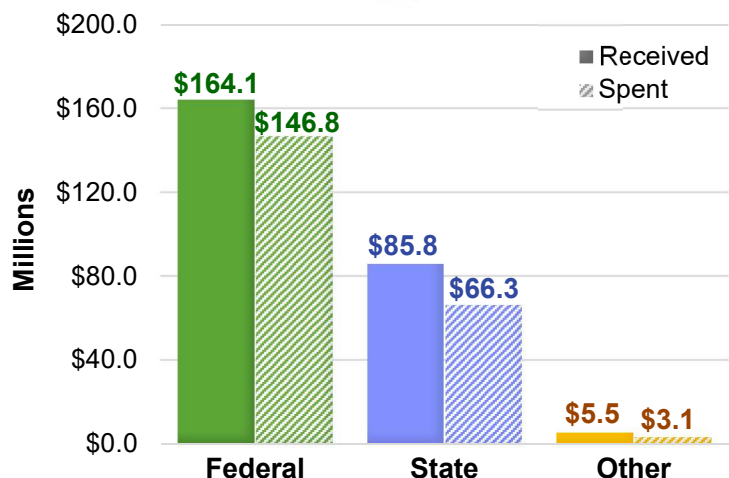

Six departments reported having workforce development programs that received funding: Commerce, Corrections, Education, Health, Human Services, and Labor and Licensing. The Department of Health reported an additional workforce program, Clinical Experiences, that did not receive any funding. The remaining nine departments reported having no workforce development programs.

**Workforce Development Funding, FY22**

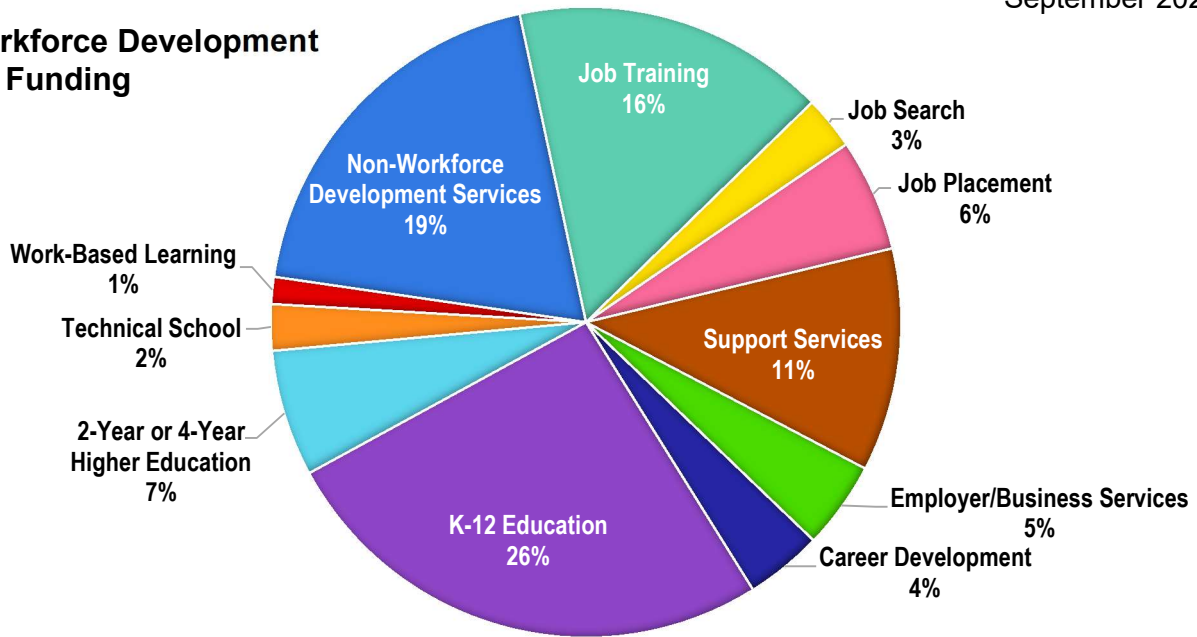


According to the survey responses received, Arkansas state agencies received a total of about **\$255 million** in state, federal, and other funding to support programs that include workforce development activities (About \$49 million of this program funding is dedicated to non-workforce development activities).<sup>1</sup>
