Ewōr jwawein ko kwo naaj aikuij loori ilo kajojo wiik me iien kōllaik wa jipañ ko.

- D. Kate joñan maroñ im kappok jikin jerbal,
- E. Bōk kunam ilo iakwelel ko ikijien jerbal, im
- F. Ejjelok men ko renaaj notaik kake

Kajjitōk Ko Ekkā Kajjitōk Kaki

Rej ke bok jāān in ax eo ñan jortoklik eo ñan iien ko ejjelok jerbal?

Jaab, kadidik ko ālnwōt tax ko rej jab ekkāñok jan check in kōlle eo wōnāām. Rijebal ro ilo Arkansas me rej lipopo iumi kakien o an Department of Eorkforce Services rej aikuij kōlle ta kajojo kuwata jan check in kōlle ko air. Tax in ej kadelok jāān in jipañ ko naaj am.

In ke bōk kōlle ilo wiik in köttar eo (Waiting Period Week)?

Jaab, kakien eo ej kemelet ber kajojo armij ro rej lelok juōn iien köttar kōmman claim (Valid paid Waiting Period Claim) ñan wiik eo jino in air maroñ bōke. Mene kwoj jab kōlle ilo wiik in, joñan jāān in jipañ elaptata rej jab kōmman kadidik ko ñane.

Ij aikuij ke bar kōmman juōn bar iien köttar (waiting period) elāñne ij bar koppelok claim eo aō? Jaab, ewōr juōn wōt iien köttar ilo iien en kwoj kōmman am claim, ljowōt ke, ne emōj an juōn claim jako kitien a n jerbal im jkwoj kōmmane ak file bar juōn claim, enaj bar eor juōn iien köttar rej lewaj.

Elañne inaaj loe juōn aō part-time job ilo terre eo ij bōke jāān in jipañ jan jortoklik in jab jerbal eo, ij aikuij ke ripote men eo wōnāān iij kōmmane ilo kajojo wiik? Aet, kwoj aikuij ripote joñan nōmba in awa in jerbal ko am im aōlepen joñan kōlle eo am ilo kajojo wiik kwoj jerbal im kōmman am claim, jekdon ia eo kwoj jerbal ie.

Ij ke ripot e aōlep kōlle eo aō (gross) mokta jan tax im kadidik ko jet (net) Ne ij kōmman aō claim kake jāān in jipañ ko kajojo wiik?

Kwoj aikuij ripote nōmba in awa ko am ilo jerbal im aōlepen men eo wōnāām ñan kajojo wiik ko kwoj kōmman am claim. Kōlle ko am kwoj aikuij ripote ilo wiik eo me kwoj kwar kōmmane - jab ilo wiik eo kwoj kōlle.

Ij kōlle ilo aō kōmman jerbal ko (production work) im ijab jela ewi joñan aōlepen men eo wōneo (gross wages) mae iien ij bōke kōlle eo aō. Ewi wewein aō maroñ kōmman claim eo ilo wiik eo elāñne ijab jela jete naaj joñan kōlle eo aō? Elanne kwoj jab maroñ jela joñan kōlle eo am ilo juōn wiik, kwoj aikuij köttar mae iien emōj am bōke kōlle eo am ñan claim eo am ilo wiik en. Kakien koi lo DWS Regulation 14(a) rej kwalok bwe, ne jerbal eo am ej ñan et wōt awa, juōn armij eo ewōr 14 rāān ko jan rāān eo kōlle ko am emōj am bōke ñan am kōmman am claim wiik eo.

Imaroñ ke ukote aō lōmnak bwe en ebij wōt federal taxes ko mae iien eo ij kōmmane bebe eo aō? Aet. Ikin an moj am kōmmane bebe eo am kake jekjek in federal tax withholding, kwo maroñ ukote bebe eo am juōn allen ilo iiō in ebbōk jāān in jipañ eo. Kwo maroñ ukote bebe eo am juōn wōt allen ilo iiō in ebbōk jāān in jipañ eo. Kepake Opjj eo ijo kwoj pād ie elāñne kwoj kōñan kōmman oktak in.



Ta eo elāñne ijab erre kōn bebe eo opjj eo an DWS ej kōmmane ikijien aō maroñ bōk jāān in jipañ ko kin an ejjelok aō jerbal?

Juōn ian rein ilo party kein (claimant or employer) me ejjab erre kōn bebe eo an opjj in an iDWS emaroñ kajjitōk bwe en eor iien kroñjake (appeal) kōn bebe eo. Opjj eo an Appeal Tribunal eo ej juōn opjj eo ej make iian bwe en kroñjake bwe en kroñjake keij eo am im kwalok juōn jemlok kāel.. Jikin kroñjake (appeal) eo juōn ikijien abnōn eo am ej ippān ro uāān Board of Review eo, im ālkin ne ejjelok tōbrak innam enaj Opjj eo an Arkansas Court of Appeals.

Ij ke aikuij bōke juōn jerbal eo ediklok wōnāān jan kar jerbal eo aō mokta?

Kajojo armij ej aikuij in kapok an jerbal, aikuij wor an kōñan bōk jerbal ko ne rej lilo me rōkkar ñane. Jerbal eo ekkār ej pedped wōt ion elon men ko – ālnwōt joñan wōnāān ilo jerbal eo, ewi aetok in am jab kar jerbal, im kar joñan kar wōnāām ilo kar jerbal eo am mokta. Kakien eo ejab lukun tarleb in ijoke wōnāām ej aikuij joñan wōt kar wōnāām ilo jerbal eo am aliktata.

Imaroñ ke jikuul ilo iiem eo ij bōke jāān in jipañ eo kōn an ejjelok aō jerbal?

Kakien eo an Arkansas ej kemelet bwe juōn armij ejn ejjelok utame ilo ālnwinin im bojak ñan jerbal ilo iien ej bōk jāān in jipañ ilo an ejjelok an jerbal, im ewōr an kōñan bōk jerbal ko rej lilo me rōkkar ñane. Ljowōtke, kwoj jab aikuij maroñ kappok am jerbal elāñne kwoj pād ilo jikuul ālnwōt juōn full-time im pād ilo course in ekatok ko emōj kwowappeni jan Department Director eo; al elāñne kwoj jikuul, full-time, ilo pirokraam ko an federal emōj kwowappeni ālnwōt ilo the Trade Act. Lale ippān ro ilo Opjj eo ijo kwoj pād ie ñan etale ne kwo maroñ pād ilo juōn ian wāwein kein ñan am jab aikuij in kappok am jerbal.



Melele ko Rej etali ñan kōmman jemloj elāñne ekkār bwe en iwoj jipañ ñan kwe ak jab im bwe kwo maroñ ebbōk jipañ ko jan Arkansas im ewi joñanāān eo kwoj maroñ kadouji. Innam kim naaj jilikin waj juōn kōjjela (Notice of Moñetary Determination) kōn joñan eo enaaj kwalok elāñne ebwe credit eo am jan men eo wōnāām ñan am kōmman am kajjitök jipañ (claim).

Ewi aetokan aō köttar ālkin aō kadedeik pepa in kajjitök jipañ ñan aō jino bōk jāān in jipañ ko kajojo wiik?


